# Constitution & Bylaw Meeting, May 28th

The board welcomes commentary and discussion of the presented document as presented, which will be included in the meeting minutes.

As the document is malleable (under 3.13 section of the Bylaws), further amendments can be introduced at future general meetings.

Amend board to 7 directors to provide continuity as the board will be stepping down as a whole at the November AGM; if motion passes, follow procedures to elect 2 new directors to the board.
